VOTING RESULTS OF ANNUAL GENERAL MEETING
HELD ON 26 MAY 2017

At the annual general meeting of the Company held on 26 May 2017, all proposed resolutions as were duly passed by the shareholders of the Company.

Reference is made to the circular (the “**Circular**”) of Springland International Holdings Limited (the “**Company**”) and the notice (the “**Notice**”) of the AGM dated 21 April 2017. Unless the context otherwise requires, terms defined in this announcement shall have the same meanings as those defined in the Circular.

POLL RESULTS OF THE AGM

At the annual general meeting of the Company held on 26 May 2017 (the “AGM”), all votes on all the proposed resolutions as set out in the Notice were taken by a poll. The Company’s branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer at the AGM for the purpose of vote-taking.

As at the date of AGM, the total number of issued shares of the Company entitling the holders to attend and vote for or against the resolutions at the AGM is 2,315,023,000 and there were no shares of the Company entitling the holders to attend and vote only against the resolutions or abstain from voting at the AGM.
